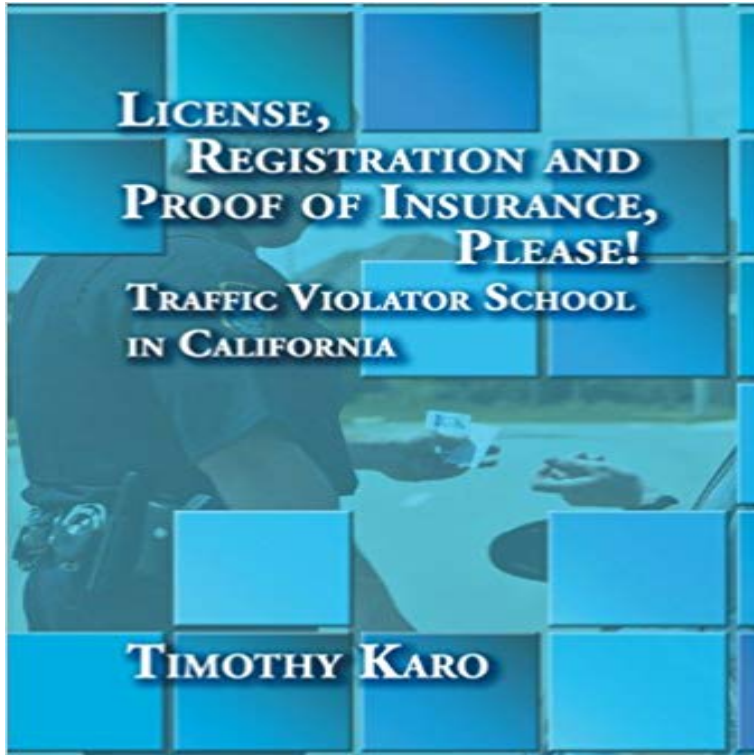


License, Registration, Proof of Insurance Please! : Traffic Violator School in California
