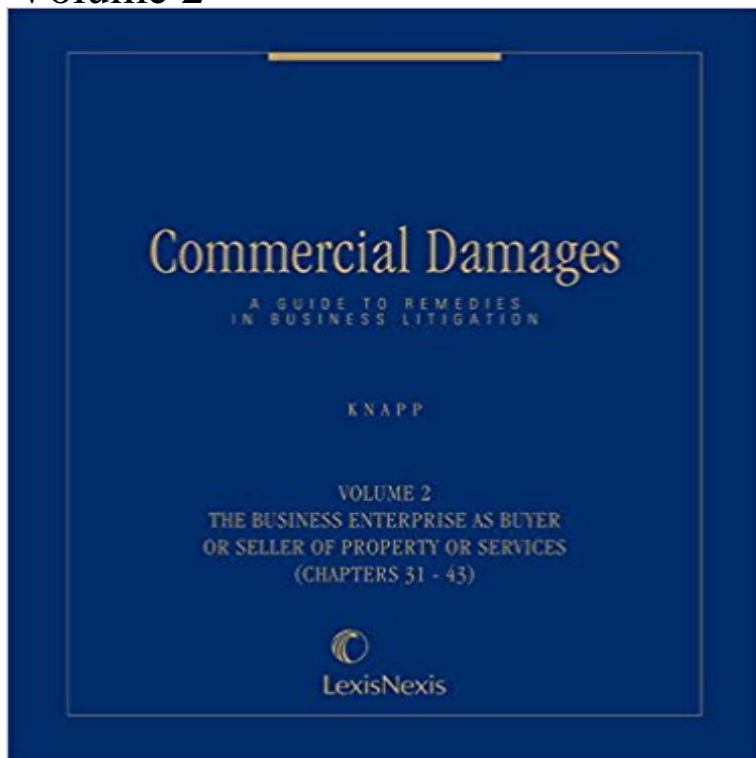


Commercial Damages: A Guide to Remedies in Business Litigation, Volume 2
