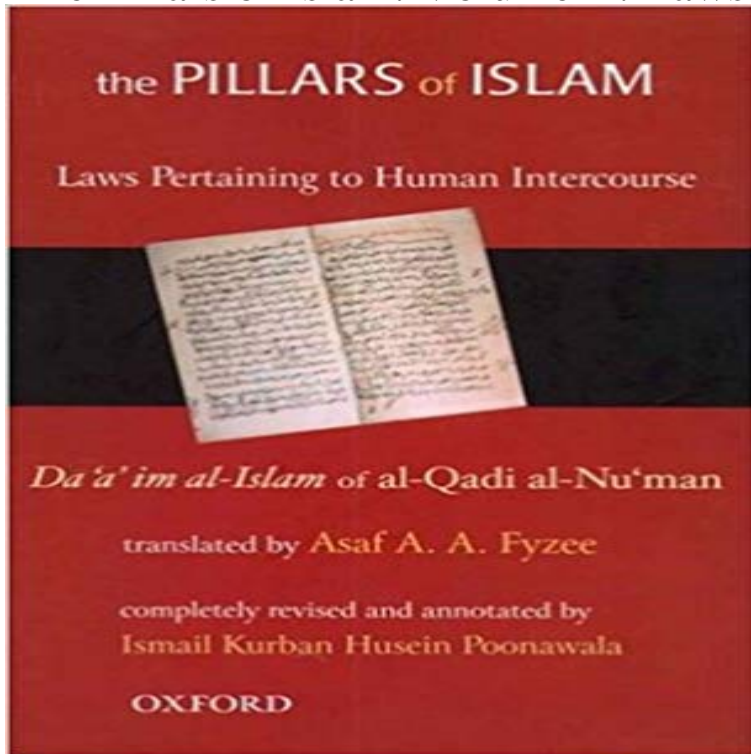


## The Pillars of Islam: Volume II: Laws Pertaining to Human Intercourse
