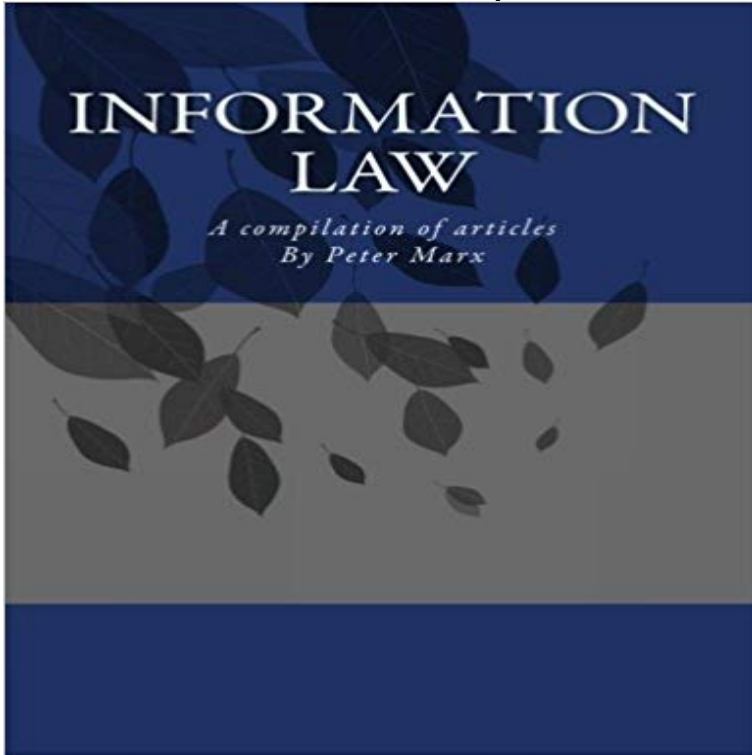


Information Law: A compilation of articles
