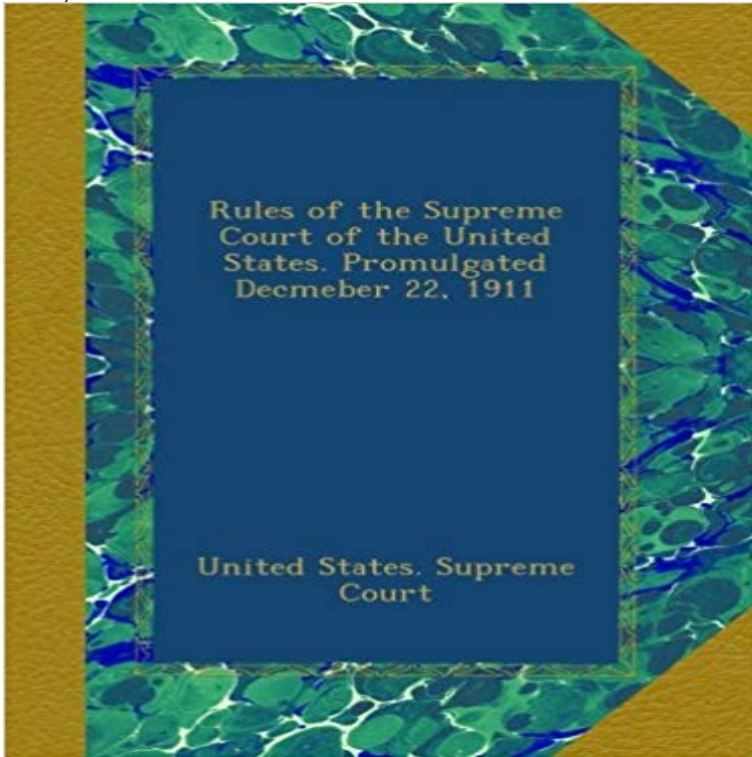


# Rules of the Supreme Court of the United States. Promulgated Decmeber 22, 1911
